

Attachment 1: Schedule of affected and adjacent land

The affected and adjacent land for the Papakura to Drury South Stage 1B1 transmission line works are identified in the table below. The table contains the following information:

- Site reference number, to be read in conjunction with the Waka Kotahi affected and adjacent parties plans within this attachment.
- Confirmation that all land in the table is adjacent land for the transmission line works. (*Note: this replaces the land status identified on the attached plans*)
- Site details, including the address, legal description and title.
- The owners of the site.
- The occupiers (if different from the owners).

Waka Kotahi have led the identification of owners and occupiers for the land affected by the Stage 1B1 Project. To inform this, Auckland Council provided a mailing list for all of the owners of the sites listed in the table below. Where the owner's mailing address was the same as the address listed in the table, it was assumed that the owners were also the occupiers and no further information was required. Where the owner's mailing address was different from the address listed in the table, it was assumed that the occupiers were likely not the owners and further information was required to determine who the occupiers were.

On 27 May 2021, Waka Kotahi sent letters to the owner's mailing address and the address listed in the table below (i.e. to the owner and the occupier) detailing the project and requesting the occupier information. The owners and occupiers were given two weeks to respond via email or phone. Those who provided responses have been recorded in the table below.
